

International Association of Tax Judges (IATJ)

The IATJ is a collective effort to bring together judges from around the world who hear or adjudicate on disputes involving direct or indirect assessments. Tax Judges for the purpose of the IATJ include Courts, Tribunals or Administrative bodies, judges or retired judges which or who, irrespective of their official title, are or were nevertheless empowered to adjudicate in tax disputes.

The newly formed IATJ will be holding its first Assembly in Rome, Italy, on August 27th and 28th, 2010.

The conference will begin on Friday August 27 with a cocktail reception and registration period from 19:00 hrs to 21:00 hrs. The meetings on Saturday August 28 will begin at 09:00 hrs with topics such as

- (a) Difference approaches to tax dispute resolution around the world;
- (b) Significant recent developments in international tax law including decisions on permanent establishment; transfer pricing; residence and VAT plus discussion on treaties and treaty amendments; partnerships flow through entity updates.

Registration for the conference is a two step procedure: the hotel reservation and the confirmation that you wish to attend the conference.
