Professor of Tax Law and was Jean Monnet Chair of the European Commission ('EU tax law') (2014-2018) at the University of Cadiz. Specialises in international taxation, including transfer pricing, and EU tax law and is the author of several books and more than one hundred articles on these subjects.

He has extensive practical experience in international taxation, transfer pricing and EU tax law, frequently acting as a consultant for (1) multinational groups, (U) HNW individuals and professional firms with international activity; (2) tax administrations and states (in tax reforms, capacity building, application of international standards or supporting them in international lawsuits and controversies), and (3) international organizations relevant in the definition of international tax standards (e.g. in 2015-2019 he was a member of the EU Joint Transfer Pricing Forum). He has also appeared in Parliamentary Commissions of the central and autonomous State, or Parliaments of other countries.

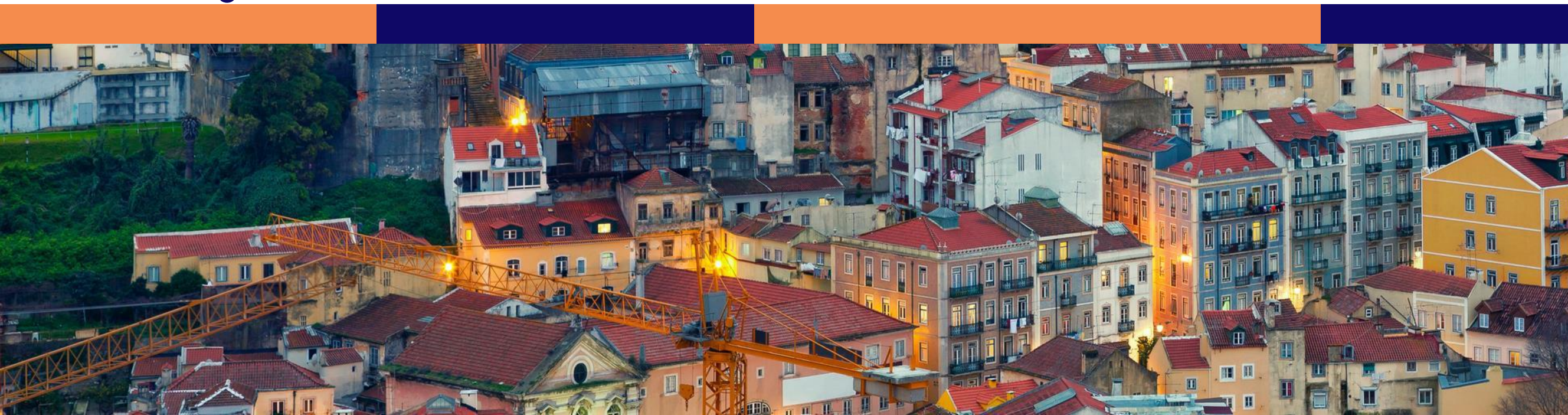
