Invitation

What is the Global IFA Travelling Lectureship Programme?

The Global IFA Travelling Lectureship Programme (TLP) is an international scientific programme uniting all five IFA Regions: Europe, North America, Latin America, Asia Pacific, and Africa; and bringing together international, regional and local perspectives on a joint tax theme, combining policy and practical aspects.

The first edition of the TLP visiting all five IFA Regions, was launched in 2024 under the initiative of Prof. Guglielmo Maisto. Prior to that, the TLP was successfully implemented in Canada: this IFA Branch originally created the initiative to support scientific dialogue among its members. Several years later, a series of Travelling Lectures also took place in the European Region, and since 2024 the TLP has evolved into a fully Global Programme. The TLP concludes at the Annual IFA Congress with a dialogue amongst the lecturers, where the key take-aways and conclusions are presented and discussed.

By fostering coordinated dialogue across all five IFA Regions and the IFA Branches the TLP visits, we strengthen the impact and reach of this collaborative effort. This global initiative is essential to supporting and shaping a sustainable and ahead-looking international tax discussion.

IFA is unique neutral and independent platform where representatives of all professions and interests can meet and discuss international tax issues at the highest level.




